Initial
What to do and bring for each class
1. Allow yourself an extra 20 minutes prior to start of swim lesson to ensure adequate time for check-in
suiting up and showering before entering pool.
2. Check in at the Health and Fitness desk on the third floor.
3. Children under 4 may accompany a parent of the opposite sex into the main locker
room, children over 4 years old should use the family changing room. Do not change children on the pool deck.
4. Only enter the water when instructor indicates class is ready to start.
5. During the lesson, parents may wait in the chairs or benches on the right side of the pool.
6. Please do not distract the instructor or the swim participants during the lesson.
7. Children who aren't toilet trained MUST wear a disposable swim diaper along
with a reusable plastic swim/diaper pant. You can purchase both at the Health and Fitness desk.
8. For non-members, only one parent/guardian is allowed to swim with student
before or after a lesson. All other guests may purchase a day pass at the
desk.

1. 48-hour notification is required to reschedule. No refunds.
2. Unused lessons expire one year from date of purchase.
4. Parents must stay in the pool area for children under the age of 6.
Group Swim Class Policies
1. We do not offer refunds or credits for missed classes nor do we prorate early withdrawals.
2. A 2-week notification is required to cancel a session and reschedule to a future session. No refunds.
3. There are no make-up lessons.
4. Registrants may attend only the class session for which they are registered.
5. We reserve the right to cancel a class with insufficient enrollment. A full refund will be made.
6. Enroll early as space is limited and group swim sessions fill quickly.
